ORDINANCE NO. 2012-01

AN ORDINANCE ESTABLISHING THE SALARY FOR THE MAYOR OF THE CITY OF CENTER POINT, ALABAMA FOR THE TERM BEGINNING NOVEMBER, 2012 FORWARD AND REPEALING EXISTING ORDINANCE 2008-01

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CENTER POINT, ALABAMA, AS FOLLOWS:

- **Section 1.** That the salary of the Mayor of the City of Center Point, Alabama, shall be and the same is hereby fixed at the sum of \$1,583.33 per month.
- Section 2. In addition to the salary provided for herein, the Mayor shall be entitled to additional compensation as provided below for the attendance and completion of Certified Municipal Official training established by the Alabama League of Municipalities, and attendance and completion of Leadership Training Institute Program levels of achievement established by the National League of Cities:
 - A. Upon attendance and completion of the prescribed courses by the Alabama League of Municipalities resulting in the awarding of the designation of "Certified Municipal Official", the Mayor shall receive an additional \$500.00 per month.
 - B. Upon attendance and completion of the prescribed courses by the Alabama League of Municipalities resulting in the awarding of the designation of "Advanced Certified Municipal Official", the Mayor shall receive an additional \$500.00 per month.
 - C. Upon completion of the prescribed courses by the National League of Cities Leadership Training Institute resulting in the awarding of the "Bronze Certificate of Achievement", the Mayor shall receive an additional \$700.00 per month.
 - D. Upon completion of the prescribed courses by the National League of Cities Leadership Training Institute resulting in the awarding of the "Silver Certificate of Achievement", the Mayor shall receive an additional \$700.00 per month.
 - E. Upon completion of the prescribed courses by the National League of Cities Leadership Training Institute resulting in the awarding of the "Gold Certificate of Achievement", the Mayor shall receive an additional \$700.00 per month.

- F. Upon completion of prescribed courses for Certified Alabama Planning and Zoning Official training program offered by The University of North Alabama, the Mayor shall receive an additional \$250.00 per month.
- **Section 3.** Upon presentation of proof of the awarding of the above listed programs' certifications, the Mayor's salary shall be increased as provided herein beginning the next pay period after being awarded the designation.
- **Section 4.** If at any time the Mayor loses any of the above listed certifications, the Mayor's salary will be lowered by the appropriate amount.
- **Section 5.** This ordinance shall become effective on the first Monday in November, 2012 and shall continue in force and effect until repealed by action of the City Council.
- **Section 6.** All ordinances or parts of ordinances heretofore adopted by the City Council of the City of Center Point, Alabama which are inconsistent with the provisions of this ordinance are hereby expressly repealed, specifically including Ordinance 2008-01.
- **Section 7.** The provisions of this ordinance are hereby declared severable; if any portion of this ordinance shall be held unconstitutional or otherwise invalid by a court of competent jurisdiction, such ruling shall not affect the remaining portions of this ordinance
